These terms tell you who we are, how we will provide our services to you, how you or we may change or cancel the Contract should your plans change etc, what to do if there is a problem and other important information.

We are members of the National Society of Allied and Independent Funeral Directors, and abide by its code of practice, a copy of which is available on request or via the link below. Members must conduct themselves in a totally professional manner, and behave sensitively, with courtesy and complete dignity at all times, both privately and professionally.

## Information on how to contact us.

You are entering into a contract with Sims and Jones Funeral Directors Limited. We are a limited company with our registered office at 240 Jersey Road, Bonymaen, Swansea, SA1 7DL. Telephone 01792 700501.

#### **Estimates and Expenses.**

Sims and Jones Funeral Directors Limited operate a pricing policy in compliance with the Code of Practice of the National Society of Allied and Independent Funeral Directors.

Our price list provides clients with a full and detailed explanation of our charges as required by the Code. We also offer a number of transparent funeral options, again, all details are set out in a detailed explanation. These funeral options include disbursements, e.g Cremation fees / Burial Fees etc.

The estimate sent to you before the funeral sets out the services we agree to supply, as requested and discussed with you. This estimate is an indication of the charges likely to be incurred on the basis of the information and details we know at the date of the estimate. While we make every effort to ensure the accuracy of the estimate, there are charges that are liable to alteration particularly with the third parties disbursements.

We will request that the third party charges are settled in advance of the funeral.

If you amend your instructions we will require your written confirmation of the changes. We may need to make an extra charge in accordance with prices published in our current price list.

We will add VAT to our charges, where applicable, and at the rate applicable when we prepare the invoice.

# **Payment Arrangements**

**Independent Funeral Directors** 

The funeral account is sent two days following the funeral and is due for payment within fourteen days of our account, unless otherwise agreed by us in writing.

If you fail to pay us in full on the due date we may charge you interest:

- at a rate of 2% above our bank's Base Rate from time to time in force;
- calculated (on a daily basis) from the date of our account until payment;
- compounded on the first day of each month; and
- before and after any Judgment (unless a Court orders otherwise).

In certain cases, the Department for Work and Pensions (DWP) may contribute to the cost of the funeral. We will give you general information about this but it is your responsibility to check whether this applies to your specific circumstances relating to this funeral. Payments made by DWP will not cover the full amount owing and you will be required to pay the remaining balance.

We request that disbursements are paid up front ahead of the funeral. This amount will be a minimum of £1000 for Cremation, and the full cost of disbursements for a Burial.

#### **Data Protection**

We will ensure that the personal data provided to us will be treated confidentially and will be held securely.

You have the right to request that we should provide you all the details we hold about you on your request. You may also request that any information we hold be edited, changed and/or deleted. This can only apply when the person themselves makes the request about their own data. Should the details of a deceased person need to be edited, adjusted or erased this can only be authorised by the person acting as the informant, in the first instance, at the time of making the arrangements.

We will use the personal data you provide to us to:

- a. provide the funeral;
- b. process your payment for it;
- c. pass to third parties who are providing services as part of the funeral as agreed with you.

All personal data will be held in accordance with our policies on data protection and privacy policies from time to time as displayed on our website via this link. http://www.simsandjones.com/privacy-policy Data Protection Regulation and any subordinate legislation relating thereto.

#### Indemnity

You are to indemnify us in full and hold us harmless from all expenses and liabilities we may incur (directly or indirectly including financing costs and including legal costs on a full indemnity basis) following any breach by you of any of your obligations under these Terms.

This means that you are liable to us for losses we incur because you do not comply with these Terms. For example, we will charge you an administration fee where we receive a cheque from you which is subsequently not honoured or if we write to remind you that an account is overdue. If we instruct debt collection agents we may also recover from you the fees we incur. Further details regarding these fees are available on request. We may claim those losses from you at any time and, if we have to take legal action, we will ask the Court to make you pay our legal costs.



## **Cooling Off Period**

The Consumer Contracts (Information, Cancellation & Additional Charges) Regulations 2013 give you the right to terminate this agreement in the cooling-off period of fourteen days. If you wish the performance of the agreement to which this right applies to commence before the end of the cooling-off period, you must sign the authority on the form which will be handed to you. In the event that you exercise the right to cancel this contract during the cooling-off period, you will be required to pay a reasonable amount for goods and services already supplied.

#### **Termination**

Right to cancel (Arrangements made in the client's home or in the workplace of the client)

You have the right to cancel the contract if you wish. This right can be exercised by sending or taking a cancellation notice to the funeral director at any time within the period of 14 days starting on the day of the arrangement. The right to cancel can be lost during the cancellation period if the service is provided in full before the 14 days elapses.

Where applicable, payment may be required to be made in respect of any services carried out or disbursements paid, once the performance of the contract has begun and prior to the cancellation notice being received.

If you wish to cancel the contract you must tell the person named below, in writing, within 14 days.

This agreement may also be terminated before the services are delivered: (1) by us if you fail to honour your obligations under these Terms and (2) by you communicating to us in writing, terminating your instructions.

# Standards of Service

The National Society of Allied and Independent Funeral Directors Code of Practice requires that we provide a high quality service in all aspects. If you have any questions or concerns about the service we provide to you, please raise them in the first instance with our designated senior person.
